Introduction

ECITB Awarding Organisation (ECITB) offers a range of regulated qualifications for the Engineering Construction Industry. Our fees are designed to be transparent, simple and clear with excellent service and value for money for our approved centres.

Fees for all approved centres effective from 1 April 2026 are listed below and correct at the time of publishing.

Learner registration fee

We charge a registration fee per qualification, per learner. The registration fee is charged at the point of registration and is non-refundable. It includes certification.

Knowledge test fee

The fee for each knowledge test is £16.00, per test, per learner.

Resits are also charged at £16.00 per test, per learner.

Other fees

Other fees are for essential and optional services, for example to become a recognised centre, to apply to delivery additional qualifications, to request an additional EQA monitoring activity (face to face/remote), or for learners to request replacement certificates.

<p>New centre recognition application fee</p> <p>This fee is chargeable in two stages:</p> <ul style="list-style-type: none"> Stage 1: Expression of interest application, including a finance and legal check £500 + VAT. Stage 2: Centre recognition application £1000 + VAT. <p>The expression of interest fee covers due diligence searches by our finance and legal teams to ensure that we approve only centres that are in good financial health and are well governed, reducing the risk to learners.</p> <p>If the application is unsuccessful at the expression of interest stage, it does not proceed to the centre recognition application stage. The stage 1 expression of interest fee is non-refundable.</p> <p>If the application passes the expression of interest stage, it</p>	<p>£1500 + VAT (£500+VAT + £1000+VAT)</p>

<p>proceeds to a centre recognition application, stage 2. The application is reviewed by an ECITB EQA either remotely or an in-person visit to the potential new centre. This involves ensuring that the centre has; the right staff in place to deliver the qualification(s) it has applied for; robust policies and processes; suitable resources and facilities.</p> <p>If the centre recognition application is unsuccessful, the fee is non-refundable.</p> <p>For those organisations who are already an approved training provider (ATP) for ECITB licenced products, the expression of interest fee is not applicable as the finance and legal check will have already been completed.</p>	
<p>Additional qualification approval fee</p> <p>If the qualification approval application is unsuccessful, the fee is non-refundable.</p>	£100 + VAT
<p>Replacement certificate fee</p> <p>Learners who have misplaced their original certificate may apply for a replacement. The certificate will clearly indicate that it is a replacement.</p>	£35 per certificate
<p>Additional EQA monitoring activities (on site visits or remote)</p> <p>All approved Centres will receive between one and four free monitoring activities annually, which may take place in-person or remotely using digital technology.</p> <p>If a centre requires more than four EQA monitoring activities in one year, this fee applies per additional visit/remote. The approved centre may request additional visits/remote activities, or ECITB may require an additional visit/remote activity, for example if an approved centre has committed malpractice or is under sanction.</p> <p>Activities may include sampling of learner evidence, formative sampling, review and/or observation of assessor or IQA decisions, meetings, observation of assessments, interviews with centre staff or learners and reviewing delivery facilities (this is not an exhaustive list).</p> <p>This fee is not applicable where the purpose of the visit is for ECITB staff training.</p>	<p>£500 + VAT per day plus</p> <p>any reasonable expenses e.g. standard fare rail, mileage, subsistence and accommodation if needed</p>
